MUTUAL AID AGREEMENT

between

Forsyth, Illinois

and

Macon County, Illinois

The Village of Forsyth, Illinois agrees to render mutual aid to Macon County, Illinois when the need arises and in times of disaster and/or extreme emergencies.

In turn, Macon County, Illinois agrees to render mutual aid to the Village of Forsyth, Illinois when the need arises and in times of disaster and/or extreme emergencies.

This agreement is subject to the availability of equipment and personnel and not otherwise leaving the respective communities without proper coverage in the event of an emergency.

This agreement will be effective immediately and will continue in effect until terminated or replaced by similar contracts between those bodies at a later date.

LEGAL AUTHORITIES

The legal authorities authorizing and providing for the preparation of this Forsyth Emergency Operations Plan (EOP) are:

- Federal Civil Defense Act of 1950;
- Illinois Emergency Management Agency Act (20 ILCS 3305 / 1 et. seq.)
- IEMA Administrative Rule on Local Emergency Operations Plans;
- Emergency Interim Executive Succession Act;
- Macon County Emergency Management Agency (EMA) Ordinance; and
- Village of Forsyth Code No. 94.01 Creating the Plan

MISSION STATEMENT

The mission of this Emergency Operations Plan is to provide a comprehensive emergency management program in response to the effects of natural disasters, technological accidents, war and other major incidents and seeks to:

1. Mitigate the effects of any hazards;
2. Prepare for measures to be taken which will preserve life and minimize damage;
3. Respond during emergencies with necessary assistance; and
4. Establish a recovery system to return the community to its normal state of affairs as soon as possible.

CONCEPT OF OPERATIONS

It is government's responsibility to undertake comprehensive emergency management to protect life and property from the effects of hazardous events. Local government bears the primary responsibility for emergency management activities. When an emergency exceeds that local government's capability to respond, or when special equipment or resources are needed assistance will be requested from the County, State and Federal governments through the office of the Macon County EMA Coordinator. County, State and Federal disaster assistance efforts are intended to supplement local response efforts and not to supplant local governmental responsibility.

A comprehensive emergency operations plan addresses numerous types of hazardous situations, which may develop in the community. The four phases of comprehensive emergency management are as follows:

1. **PREPAREDNESS** activities serve to develop the response capabilities needed in the event an emergency should arise. Planning and training are among the activities conducted under that phase.
2. **RESPONSE** is the actual provision of emergency services during a crisis. Those activities help to reduce casualties and damage and to speed recovery. Response activities include warning, evacuation, rescue and similar operations.
3. **MITIGATION** activities are those designed to eliminate or reduce the probability of a disaster occurring in the first place as well as long-term activities believed to lessen the undesirable effects of unavoidable hazards.
4. **RECOVERY** is both a short-term and long-term process. Short-term operations seek to restore vital services to the community and provide for the public's basic needs. Long-term recovery focuses on restoring the community to its normal, or improved, state of affairs. The recovery period also is an opportune time to institute mitigation measures, particularly those related to the recent emergency.

Emergency response operations may utilize all available resources (governmental and private). Since local government will be the primary resource around which a disaster operations organization will be developed, appropriate emergency functions are assigned to the various agencies or departments of local government, which are consistent with their normal, day-to-day responsibilities.

ACTIVATION AND IMPLEMENTATION OF THE PLAN

This plan relies on the concept that the response to any disaster always should be at the lowest possible effective level.

All departments and resources of the Village of Forsyth, including standard mutual aid agreements, may be utilized as appropriate during disaster operations.

If those resources are inadequate, additional assistance will be requested from Macon County through the Macon County EMA.

If Macon County resources are inadequate, then assistance will be requested through Macon County EMA from nearby jurisdictions and/or the State of Illinois to help return the Village of Forsyth to pre-disaster conditions.

DIRECTION AND CONTROL

Effective leadership, coordination and unified on-scene command are required to effectively respond to any incident. Each department will assume the responsibility for carrying out its duties of emergency management.

The overall command of all emergency operations is the responsibility of the Village Mayor or his or her designee. The Village Mayor will direct the emergency response measures of each Village department or organization.

The decision to implement the emergency operations plan will be based on the probability, or the actual occurrence, of a disaster that threatens the public health, safety and welfare of the populace of the Village of Forsyth or which has the potential for overwhelming the Village's resources.

In such an event the Forsyth Public Safety Director will contact the Village Mayor to inform him or her of the situation and receive directions concerning the implementation of the Emergency Operations Plan.

The Forsyth Public Safety Director will evaluate the situation and advise the Village Mayor on courses of action available on major issues. During emergency operations the Forsyth Public Safety Director is responsible for overseeing the interaction of the Village department heads. The Public Safety Director also is to act as the liaison with other local, state and federal emergency management agencies involved.

MEANS FOR REQUESTING ADDITIONAL ASSISTANCE

Should the resources of the Village prove to be insufficient or inadequate in any emergency situation, then, the Forsyth Public Safety Director will contact the Macon County EMA Coordinator to request County resources and assistance. When State disaster assistance is needed the Forsyth Public Safety Director will serve as liaison to Macon County EMA and will provide the Macon County EMA with specific information about the impact of the disaster on the Village. Macon County EMA, in turn, will provide that information to the IEMA Region 7 Coordinator, if available, or to the IEMA State office in Springfield. If needed, Federal resources also will be requested. Regardless of how many levels of response are involved, local officials always will maintain ultimate control and responsibility.

Government alone cannot respond to all disasters. Volunteers will be accepted (when doing so will not put them at extreme risk) and utilized to the full extent of their capabilities in accordance with the IEMA Act. This enrollment of all volunteers shall be in compliance with the oath as stated in the IEMA Act.

CONTINUITY OF GOVERNMENT

EXECUTIVE LINES OF COMMUNICATION

If the Village Mayor is not available to assume command and direct emergency response operations, then the following chain of command will be followed by authorization to implement any section or part of this plan will be determined by:

1. Village Mayor
2. Village Mayor Pro Tem
3. Village Public Safety Director
4. A Person Designated by the Village Public Safety Director

The line of succession in each Village department will be according to the operating procedures established by each department.

Under the direction of the Village Mayor, each department head or designee will direct his department according to the preplanned emergency operations procedures designated for that department.

PRESERVATION OF RECORDS

It is the responsibility of the elected officials to ensure that all legal documents, of both a public and private nature, recorded by that official (i.e. Village clerk, treasurer, etc.) be protected and preserved. Those records must be kept to support continuing government functions and emergency operations.

PROVISIONS FOR UPDATING THE PLAN

The Village Public Safety Director will have primary responsibility for maintaining and updating this Forsyth Emergency Operations Plan, including collection of new information and making of changes in:

1. Chain of Command
2. Communication Equipment
3. Telephone Numbers
4. Personnel
5. Resources
6. Emergency Operating Procedures

Each department will assist the Director in maintaining and updating this plan by forwarding changes, as they occur, to the Village Public Safety Director.

A standardized method for reviewing and updating this plan will be performed under the following conditions:

1. Review and revise as needed, but at least every two (2) years.
2. Revise as changes occur in personnel, equipment, resources, reporting methods and operating procedures.
3. Review and revise after conducting any simulated exercise of the plan and holding a formal critique of the exercise results.
4. Revise as new emergency management services are established.
5. Revise as new information and techniques are discovered that improve the efficiency and overall effectiveness of the emergency management system.
6. Review and revise after an actual emergency or disaster has occurred and each responding agency critiques the disaster response.

The Village Public Safety Director will forward any and all changes to all holders of copies of the plan.

PROVISIONS FOR EXERCISING THE PLAN

The Forsyth Emergency Operations Plan will be exercised and tested within six (6) months of its formal approval and adoption by the Village Mayor.

Thereafter, the plan will be exercised and tested in accordance with the minimum federal requirements, which currently is every four (4) years.

Any emergency preparedness exercise or test may be held during the annual tornado drill, a hospital drill or any other scheduled drill, but preferably in conjunction with a county or countywide exercise.

If an actual disaster occurs which calls for the activation of this plan and which meets FEMA requirements, then an emergency preparedness exercise will not be required during that calendar year.

The Village Public Safety Director will have the responsibility for coordinating emergency preparedness exercises. He or she will designate the date, time and location for each exercise. Information and guidance on emergency exercises may be obtained from IEMA through the County EMA Coordinator.

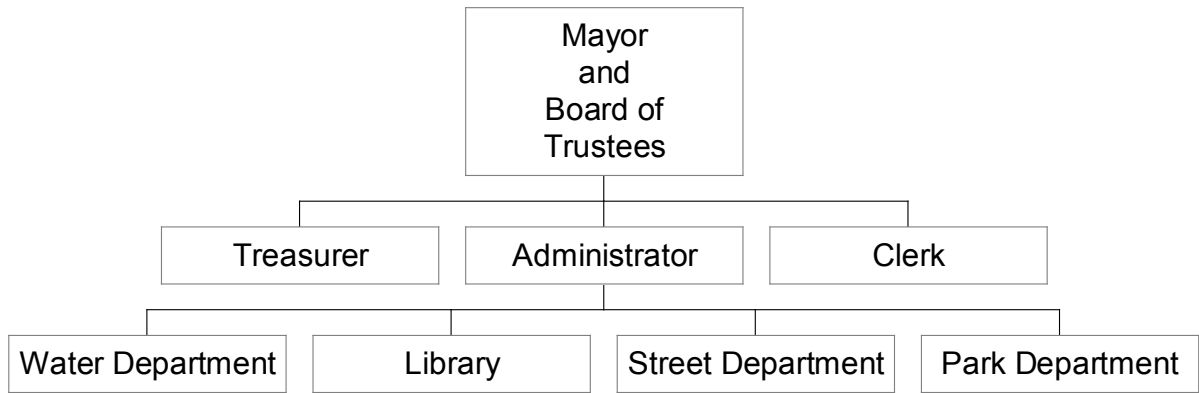

EVACUATION

Emergency situations might require either small scale, or mass evacuations. Small scale or localized evacuations might be needed as a result of flash flooding or a hazardous materials accident. Mass evacuation could be required in a major catastrophic event or enemy attack. Evacuation of significant numbers of people may occur with substantial warning as in flood warnings or with little warning as in the case of a toxic chemical spill.

Standard operating procedures plus additional instructions for response to specific hazard:

- *Radiological Incident
- *Chemical Incident
- *Fire
- *Aircraft Accident
- *Explosion, unexploded bomb or other munitions

Determine if there are any hazards to personnel. In emergencies with little or no warning, the decision to evacuate is made by the chief on-site officer of either fire or law enforcement agencies. When time permits procedure for Direction and Control are to be followed. Notify Macon County Emergency Management Agency and/or State of Illinois appropriately.

***EMA** is the overall authority for an evacuation requiring their efforts. All activities will be coordinated through the EOC, which serves as the source for all direction and control.

In most situations evacuations are voluntary. In some incidents, such as certain types of hazardous materials emergencies, the presence of people may cause an explosion or other serious problems. In the event, forced evacuations may be necessary.

***CONSIDERATION:**

- Inventory all emergency response resources i.e., personnel (including fire and rescue service, transportation service, law enforcement service, shelter groups, equipment and supplies)
- Determine magnitude, intensity, spread of on set, and duration of hazard
- Identify number of people at risk
- Calculate time and distance of travel necessary to insure safety
- Activate Crisis Relocation Plan
- Determine availability of evacuation routes, their capacities, and vulnerability to the hazard
- Assure mode of transportation for those persons unable to supply their own

- Initiate recovery (return when and where possible)

FIRE STANDARD OPERATING PROCEDURE PLUS:

Make sure 911 has been called, and that the Hickory Point Fire Department has been notified. The local Fire Chief or OIC is in charge of all operations concerned with the prevention, control, and investigation of fires. The Incident Management/Incident Command System will be utilized with other officers and mutual aid. Upon request of the Fire chief, law enforcement agencies, the Public Safety Manager, and/or EMA will mobilize additional resources to assist with traffic control, evacuation, communication, transportation, and are security.

Automatic mutual aid will have been dispatched through County Dispatch to Warrensburg FD and Maroa FD, if it is a structure fire. Additional mutual aid may be requested through County Dispatch for Latham, Argenta-Oreana, and Clinton fire department. Decatur is on a different radio frequency making communication difficult, but would also be available for mutual aid.

CHEMICAL INCIDENT (HAZARDOUS MATERIALS) STANDARD OPERATING PROCEDURES PLUS:

Call 9-1-1 to notify Macon County Sheriff and EMA as required by Illinois Hazardous Material List (PA 79-1442) and per Title III, SARA, 1986. In the event that material is classified radioactive contact Ameren/IP Company.

Cordon off area and ALLOW NO ADMITTANCE except for rescue. Evacuate all persons from downwind areas. Be alert for fire causing the possibility of hazardous fumes also any other hazard, which may be created by the chemical. The proper qualified personnel from appropriate agencies (Macon County Sheriff, EMA, Ameren/IP) should determine the exact nature of the chemical involved and its characteristics before any attempt is made to neutralize or dispose of the Hazardous Chemical spill. Expert assistance should be brought in to supervise this type of incident.

RADIOLOGICAL INCIDENT (HAZARDOUS MATERIALS) STANDARD OPERATING PROCEDURES PLUS:

Call 9-1-1 to notify Macon County Sheriff and EMA as required by Illinois Hazardous Material Act (PA 70-1422). In the event of a nuclear radiological emergency contact Ameren/IP Co.

Cordon off area and ALLOW NO ADMITTANCE except for rescue. Evacuate ALL persons from downwind area. This is especially important if fire is involved. Contamination may be present in the area or on personnel and equipment involved. All personnel and equipment involved must be held at one place; and check for contamination with instruments. THIS IS IMPORTANT.

AIRCRAFT ACCIDENT STANDARD OPERATING PROCEDURES PLUS:

Call 9-1-1 to notify Macon County Sheriff and EMA.

PRIMARY CONSIDERATIONS:

Rescue the injured and evaluate potential hazards to the surrounding area. Possibilities may include explosives, hazardous fumes, fire, fuel and cargo detonation, oxygen canisters, ejection seat etc. If fire and fumes present, evacuate downwind area.

Access to crash site should be established and maintained. **ALLOW NO ADMITTANCE TO AREA**, except minimum personnel necessary for rescue and fire fighting. Keep access clear of non-essential personnel.

Secure the crash site and any area where parts are likely to be found. Preserve the dead without moving, if possible. Document any alterations to debris where necessary for rescue operations.

SECONDARY CONCERNS & ADDITIONAL INFORMATION;

Identify the aircraft; public, private, commercial, military etc., and get any identification number available. Call information to Decatur Airport tower and/or St. Louis flight service station. If military aircraft, they control site until they release it. All aircraft have various amounts of material in their construction that become hazardous when burned. Hospitals are equipped to handle large aircraft disasters and should be alerted. All aircraft are equipped with ETL, Emergency Transmitter Locators. They will let the Control Tower know when an aircraft is down, but will not pinpoint exact location.

TORNADO OR SEVERE THUNDERSTORM STANDARD OPERATING PROCEDURES PLUS:

Call (9-1-1) advise the dispatcher of funnel cloud sightings, damage caused by high winds or lightening. Move to a safe place until the immediate storm danger has passed. When it is safe to do so:

1. Check for hazards created by the storm and control them: fire hazards-electrical wires down-gas leaks- buildings or structures in danger of collapse.
2. As soon as conditions permit, send personnel to search for injured or trapped persons. Use care in removal so as not to further injure persons or cause collapse of structures, explosions, or fire, etc.
3. Establish emergency communications as soon as possible. Brief EMA Coordinator on the situation; status of water, power, police, fire, and resources such as maintenance personnel; resources needed from other sources; ability of local government to function.
4. Advise any responding emergency personnel of any main routes closed by fallen trees or power lines. Request necessary emergency personnel to protect property from further damage if possible.

UNEXPLODED BOMB OR OTHER MUNITIONS STANDARD OPERATING PROCEDURES PLUS:

Call 9-1-1 to notify Macon County Sheriff and EMA.

Evacuate and cordon off the area until competent removal personnel arrive. DO NOT attempt removal or deactivation. Prepare to combat fires, gas leaks, electrical hazards, etc. which might result if detonation should occur.

In the event of military munitions, the STATE POLICE BOMB SQUAD will contact and enlist the services of the U.S. Army at Ft. Leonard Wood, Mo. The Army's normal response time is approximately 8 hours; however in the event more expeditious response is mandated, they have access to aircraft and can arrive more quickly (The STATE POLICE BOMB SQUAD advises that the Army will respond more quickly to a request from the STATE POLICE than to a request from a local governmental entity and therefore it is recommended that we allow the STATE POLICE to contact the Army if necessary.

Generally, the threat caused by an "UNEXPLODED BOMB OR OTHER MUNITIONS" will be eliminated within 24 hours. There is little, if any, need for resources other than the above. In the event other resources are required, such will be identified by any of the above agencies and will be of a nature similar to the resources required in the event of any other emergency (temporary housing, fire department, local law enforcement, etc.) Therefore it is not necessary to develop an exhaustive list of resources to respond to this emergency.

PUBLIC LAND TRANSPORTATION ACCIDENT STANDARD OPERATING PROCEDURES PLUS:

Notify County Sheriff as to the extent and severity of accident so sufficient and proper aid may be called. Notify closest representative of the transportation company involved. Confine first efforts to rescue and fire fighting. Cordon off the area and be alert for explosion, fire and chemical hazards.

Consideration must be given to the cargo and/or number of passengers involved in the accident. Conditions can range from a single truck with driver to a scene with multiple vehicles with a large number of passengers. Cargo may include livestock, and/or farm produce.

OPERATIONAL CONSIDERATIONS

NOTIFICATION OF ESSENTIAL OFFICIALS

This will be accomplished by the Emergency Communications Center with the assistance of the Forsyth Public Safety Director and County EMA.

PRIORITY OPERATIONS (Hurry Slowly and Carefully)

- Control of hazards or potential hazards
- Search, rescue, and medical attention for the injured
- Evacuation of persons from hazardous areas
- Safety of operating personnel and others in the area
- Control of access to and security of the disaster area
- Evaluation of the situation

ESTABLISHMENT OF A COMMAND POST AT THE SCENE

An area with good access should be acquired as close to the disaster scene as practical to serve as operational headquarters for all emergency services. Accessibility, expected length of operations, equipment and personnel to be involved, and weather conditions should be considered in selecting the site. This area may also serve as a supply depot and parking area for essential vehicles. The communications center should be located here so that all communications systems may be integrated. Macon County EMA can provide its Mobile Command Post to supplement any fire department command vehicles.

ADMISSION TO THE DISASTER AREA

All emergency vehicles of Sheriff, State and Local Police, EMA Coordinator, Fire Departments, Coroner, and other essential officials should be admitted at once. If a safety hazard exists (explosion, fumes, etc.), they MUST be warned of the danger and told the proper safety precautions to take.

Other essential vehicles (mutual aid teams, ambulances, doctors, nurses, utility and highway crews, Red Cross damage assessment teams, and news personnel) can be admitted if no hazard exists. If their presence is essential in a hazardous area, they must be warned of the specific dangers and proper precautions taken for their safety. Relatives of persons involved in the disaster and others having important business in the area should be admitted if there is no hazard and interference with emergency response work can be avoided. Their vehicles should be diverted to a parking area and made to remain there. The incident Public Information Officer will issue press passes, which will be the only authorization for entry to the disaster area by the press.

TRAFFIC CONTROL

No parking should be allowed on roads close to the disaster area. Spectators and curiosity seekers should be kept moving and diverted away from the area. Assistance from the highway department may be necessary in closing off the area. Traffic control points may be necessary some distance from the area.

AMBULANCES

Regular ambulances should be used for transportation of the injured, if at all possible. Other vehicles should be used only in extreme emergency, and then with caution.

DEGREE OF MOBILIZATION

The Forsyth Public Safety Director, EMA Coordinator, Sheriff, and other local officials should determine, at the earliest possible time, the scope of the disaster operation and decide upon the extent of manpower and facilities to be mobilized for the operation. If an extended operation is indicated, consideration should be given to shift relief, food, water and sanitation facilities for personnel, traffic control signs and barricades, consolidation of communications, emergency power and lighting, security measures, transportation, shelter of supplies, etc.

SUPPORT OF MILITARY FORCES

All requests for support by Military Forces will be channeled through the County EMA Coordinator to the IEMA Regional Coordinator. If unavailable, direct contact with IEMA in Springfield is authorized.

AVIATION SUPPORT

All requests for aviation support will be channeled through the County EMA Coordinator or the IEMA Regional Coordinator. If unavailable, direct contact with IEMA in Springfield is authorized.

HELICOPTER - AIR EVACUATION

Requests for evacuation by helicopter will be channeled through the County EMA Coordinator or the IEMA Regional Coordinator. Helicopter assignment will come from the Illinois Department of Transportation (IDOT) or National Guard, in that order.

SEVERE WEATHER WATCHES AND WARNINGS

DEFINITIONS

WATCH: An advisory that weather conditions are such that severe thunderstorms, damaging winds, large hail and/or tornadoes are expected to develop somewhere within a specific area during a certain time period.

WARNING: A warning advising that a tornado or other dangerous storm actually exists in the real and immediate protective action must be taken by persons along and near its projected path. (Outdoor warning sirens are activated when a Tornado Warning is issued by the National Weather Service or a confirmed tornado or funnel cloud threatens the area.)

ALL CLEAR: There is no "all clear" signal from outdoor warning sirens. Local EBS (Emergency Broadcast System) radio stations (WSOY) should be monitored on battery-powered radios to determine when all danger has passed and normal activities may be resumed.

RESPONSIBILITIES

NATIONAL WEATHER SERVICE: This agency originates and issues severe weather watches and warnings.

ILLINOIS STATE POLICE: This agency disseminates severe weather watches and warnings to the Sheriff of each county and receives an acknowledgement.

EMERGENCY COMMUNICATIONS CENTER: This department passes the warning on to designated officials in the county and in each city, town, and village and to the people in unincorporated areas.

MACON COUNTY EMA: This agency is responsible for the organization and coordination of all severe weather activities within Macon County. EMA will maintain the Emergency Operations Center and assure that it is operational on short notice. It will organize the operation of the "Macon County Weather Watch". The Village EMA Coordinator will notify the County EMA of any sightings. The County EMA will advise the National Weather Service of any tornado sightings and will ensure the verification of any sightings by the general public.

LOCAL RADIO/TV STATIONS: These stations will broadcast severe weather watches and warnings to the public upon receipt from the weather service, Sheriff's Department, or County EMA.

CITY, TOWN AND VILLAGE OFFICIALS: Local officials should establish a LOCAL WARNING POINT for the expedient receipt of warnings. Local weather spotters should be alerted to post watch if a weather watch advisory is received or if weather conditions so warrant. A procedure should be developed to sound the "ALERT" siren signal if a funnel cloud or tornado

is actually sighted and is approaching the community. Officials should keep schools and other public gatherings advised. Tornado sightings or storm damage should be reported to the Emergency Communications Center (which will notify Macon County EMA).

PUBLIC: The public should tune in local radio stations to receive severe weather information. They should be alert for tornadoes or dangerous storms which may develop without the knowledge of the weather service or local authorities. The public should NOT place unnecessary calls to radio stations or local authorities. All available information will be broadcast as soon as possible and will be repeated often. Report any storm damage or casualties to the Emergency Communications Center (9-1-1).
